#### PAYMENT

- 3.1 Payment plan as opted by Applicant/Allottee shall only be allowed to change at the company's sole discretion
- 3.2 Timely payment of the Sale Price of the flat as per schedule is the essence of the Agreement.
- 3.3 No late installment shall be accepted beyond a period of 45 days from due date. Interest chargeable on late payment is 15% per annum.
